

I have questions about the annual meeting. Who do I contact?

I am a mutual policyholder and plan to attend the annual meeting. Do I need to RSVP?

No, but you will need to register prior to the beginning of the meeting. Registration begins at 9:30 a.m. and the meeting will start at 10:30 a.m. A piece of government-issued photo identification will be required to register.

If you have appointed a proxyholder to attend the annual meeting on your behalf, your signed proxy form must be received before 10:30 a.m. on April 23, 2019. Your appointed proxyholder will also need to register in the manner described above.

What is the proxy cut-off date?

For the 2019 annual meeting, the deadline to vote in advance or appoint a proxyholder is 10:30 a.m. on April 23, 2019. After that deadline, the only way to cast a vote is in person, at the meeting. More information can be found in our management proxy circular.

If I attend the annual meeting, can I take photographs or record it?

No. Photography and video or audio recording of the meeting will not be permitted (other than by pre-authorized media and Economical's communication staff).

Will there be a webcast of the annual meeting?

No, the meeting is an in-person, private event.

I need an additional copy of the material that was mailed to me. How do I get one sent?
